Sep 2 – Manuel/Karen Rodriguez, Karen Collins and Mitchell Bush met for dinner at the Atlantis Restaurant in Alexandria, VA before the monthly AIS meeting at the Church of St. Clement. After the meeting, Mitchell headed out to the Onondaga Nation.

Sep 3-5 – Mitchell Bush arrived at the Onondaga Nation in the afternoon, just after a reburial ceremony at which 180 fragments from Susquehannock Indians reclaimed through the Native American Graves Protection and Repatriation Act (NAGPRA) program were laid to rest on the Gonyea/Bush family holdings. In addition to Tony Gonyea and Wendy Gonyea, both Faithkeepers in the Longhouse Religion, brother John Gonyea and Andy Fish (who conducted/oversaw the reburial) were present, as well as the young Onondaga men who operated the backhoe to dig the pit for the remains. Mitchell's brother, Stephen Gonyea, had returned to Virginia earlier that afternoon. Mitchell feasted on string bean soup and marinated cucumbers from brother John's garden. John's vegetables were prize winners at the Indian Village (IV) at the New York State Fair... On Friday, Mitchell traveled to the State Fairgrounds for Indian Day, as did the Gonyea/Homer/Thomas family grouping. Mitchell's nephew, Frank Hyde, demonstrated painting in the IV. Mitchell met Olive Ward at the cookhouse and Wanda Wood Lyons in the IV. Floyd Elm was MC for the dance program at the IV turtle mound. And Stewart Jamison was among the spectators as was Liz Obamsawin... On Saturday, the family gathered for a coney/hamburger/hot dog lunch before Mitchell returned toward VA. See separate report for his visit to the powwow held on City Island in Harrisburg, PA.

Sep 3-20 - Laughing Daughter a musical written by Roger Penycate played at the Black Box Theatre in Indian Head, Maryland. The musical had 3 local natives in the production: KJ Jacks, Jeff Barehand and Natalie Proctor, and all three did a wonderful job. Sep 4 – The Shinnecock Tribe hosted its 66th annual powwow, a four day event, at its home reservation in Southhampton, Long Island. AIS members who traveled to the powwow reported beautiful weather and a nice presentation. Blackbear (Pete Neconie, Jay and Josh Hill, Greg Sharp, Page Burgess, Dustin Big Mountain) sang. Dancers (all prize winners) were as follows: Josh Hill (1st in Men's Fancy and Special), Katie Issenock (1st in Women's Fancy Shawl), Shawndae Sharp and Donita Neconie (3rd and 4th respectively in Women's Traditional), Pete Neconie and Page Burgess (1st and 2nd respectively in Southern Straight), Jay Hill (2nd in Men's Fancy and 3rd in a Special) and Alexis Hill (1st in Junior Girl's Fancy). The group camped out during their stay in Southampton. Rob Brown, Erlette Lamont, Osa Kote Sharp and Chaske Hill were along for moral support.

Sep 5 – On his way back to Virginia, Mitchell stopped at the Dawson residence on a mountaintop near Lingleston, Pennsylvania. He followed Vivian/Haley Dawson down the mountain to City Island (Riverfront Park) to attend the 13th annual Native American Powwow held Saturday/Sunday/Monday. The event is also called "Kipona: A Celebration of Sparkling Water." In addition to powwow dancing there were performances by the Aztec dancers, Jan Seiden/Jeff Ball (flutists) and Lowery Begay (hoop dancer/performer). The emcee was Rick Hostette (Shawnee), head lady Elizabeth Johnny John (Allegany Seneca) and three drums (Old Bridge, Mother's Daughters and Wolf Nation from Chesapeake, VA). There were many vendors, teepees and a food booth which featured elk, buffalo meats and fry bread/Indian tacos. Our new AIS Princess, Haley Dawson, danced and was given a place of honor in the grand entry. In late afternoon, Mitchell left the powwow and returned to Virginia.

Sep 5 - The DC Drum Circle kickoff event took place at Lincoln Park in Washington, DC. It was a small group, in part due to a change in the originally scheduled location. Dennis Zotigh shared teachings, stories, and songs from many nations and locations east/west/north/south. The weather for the event was overcast on Saturday and bright and Head staff consisted of Mel Whitebird sunny on Sunday. (emcee), Keith Anderson/Adrienne Harmon (head man/lady dancers) and Nanticoke Singers/Red Earth/Red Blanket (drums). AIS members who served as vendors included Ray/Angel Couch, Linda Steele, Chuck/Danita Tsinnie and Ellen Whitebird. The AIS taco booth, which has been present since the first Nanticoke powwow, was operated by volunteers Eve Hill, Tim Hill/Tammy Umbel, Phil/Cathi Hill, Steve/Nick/Ciera Hill, Tia Gibbs, Michael Nephew, Karen Collins, Karen/Manuel Rodriguez, Rick/Tahj Vaughan, Eloise Giordano and Mitchell Bush. Chuck Tsinnie helped out in the booth on Saturday and his daughter, Katrina, came by and volunteered her help also on

Saturday. Our AIS Princess Haley Dawson and Junior Princess Alexis Hill both took part in Saturday's grand entry. On Saturday, after the powwow, Manuel/Karen Rodriguez, Karen Collins, Mel Whitebird, Tim Hill, Tammy Umbel, Paul/Joyce Browne, Eve Hill and Mitchell Bush met for dinner at the Cracker Barrel Restaurant adjacent to the Econo Lodge Rehoboth where the group stayed. Our volunteers worked their tails off and took in over \$9,000 before hotel/booth expenses were deducted. Among the AIS members/friends who attended for moral support were Mike White Eagle (son of Charles/Loretta), Fred/Elisha Killian, Nelson Sheppo, Pecita Lonewolf and Odette/Sharkey Wright. AIS members who danced included Marcos/Dorothy Almanza, Paul/Joyce Browne, Tim Moore, Tiombe/Cynthia Vaughan, Boe Harris, and of course Haley and Alexis. Our thanks to Karen Collins, Steve/Eve Hill and Mitchell Bush who handled the supplies. A big "Thank You" to Manuel/Karen who were about to cross the Bay Bridge on their way home when they spotted Karen Collins sitting under a light patiently waiting for someone to drive her/Eve over the bridge. Manuel/Karen saved the day.

Sep 12-13 – The Mohawk Nation at Akwesasne, NY, on the United States/Canadian border, hosted the Akwesasne International Powwow. In the dance competition, Jay Hill placed 3^{rd} in the 50+ men's competition, Josh Hill took 2^{nd} in the Men's Fancy and Katie Issenock took 2^{nd} in Women's Fancy. Along for moral support were Rob Brown, Erlette Lamont and Chaske Hill. The group camped at Akwesasne.

Sep 14 – Karen Collins, Chuck/Judy Gray and Mitchell Bush met at the Stafford Diner for breakfast. Herb Bush, Brandy Berger, Tom/Gina Vobornik and Trever Ottinger had breakfast/coffee earlier and had just left. After breakfast, Karen and Mitchell counted the monies from Nanticoke at Brandy's home and prepared a report for the AIS Treasurer. Mitchell turned the money over to the Treasurer a few days later at the Executive Board Meeting.

Sep 15 - The Virginia Council on Indians (VCI) held a regular meeting in the General Assembly Building (GAB) at the State Capitol in Richmond. VCI members present included Earl Bass, Chief Kevin Brown, Frank Adams, Sherry Munford, Sharon Bryant, Chief Anne Richardson, Reggie Stewart, Joanne Howard and Mitchell Bush. Deanna Beacham (VCI staff) and Eric Gregory (AG's staff) were also present. Guests included Allard/Lynette Allston, Archie Elliott, Beth Roach, Kenneth Munford, Loleta Bass and Sherri Rose... The meeting was called to order at 6:35 p.m. and the invocation given by Jerry Stewart... Under Administrative Business, VCI members and guests introduced themselves. The minutes of the May 19, 2009 business meeting were approved. Deanna reported on the VCI budget. Elections of VCI President and Vice President were held. Earl Bass was elected President and Frank Adams was elected Vice President... Under Public Comment, Archie Elliott requested and received a copy of the budget report... Under New Business, Reggie proposed VCI become involved in the effort to protect culturally significant places in the Chesapeake Bay, Anne seconded and the motion passed with one abstention. DCR has asked VCI to be a partner for the 40th Anniversary of the State Scenic River program in 2010. Sharon made a motion, seconded by Anne, and

carried unanimously to send a letter of support. The annual VCI Conference was discussed. Decision to be made about the conference later... There was no Old Business... Under Announcements, next VCI meeting October 20 at GAB, the 58th Annual Chickahominy Powwow will be held September 16-17 at the Chickahominy tribal grounds. Monacan Homecoming/Bazaar on October 3. The 11th Annual Rappahannock Powwow October 10 in King and Queen County. Professor Bob Miller speaking at UVA on October 12. Gabrielle Tayac article on Walter Plecker in fall issue of NMAI publication. Frank discussed the Native American Indian Chamber of Commerce. Fundraisers are scheduled for September 19, September 18 and October 2. Kevin announced that Pamunkey Indian Joyce Krigsrote will receive an award at this year's Folklife Festival in Richmond.

Sep 17 – The AIS Executive Board held its annual meeting at the Harvest Moon Restaurant in Falls Church. The main purpose of the meeting is to select new chairpersons for our various committees. Executive Board members present were Michael Nephew (President), Riccaree Vaughan (First Vice President), Pete Neconie (Second Vice President), Mary Sunbeam (Treasurer) and Cathi Hill (Secretary). Mary Sunbeam brought up several issues of concern to her. Decision made for AIS to pay for all dinners.



Sep 18-29 – Manuel and Karen Rodriguez traveled to the beautiful Smoky Mountains in Tennessee to attend the 11th Annual Holston Conference Gathering at Coker Creek Village in Tellico Plains (<u>www.thegathering.us</u>) and to visit family in Chattanooga. The Gathering is hosted by the Holston Conference, Native American Ministries Team and features workshops, devotions, storytelling, a mini powwow, and a concert featuring Bill Miller (Mohican/German) (Mr. Miller is also a featured speaker/spiritual leader). Charles Robinson (Choctaw) of Red Road Ministries (theredroad.org) was another featured speaker. Lowery Begay (Navajo) taught a workshop on hand drum making and served as Arena Director for the powwow and

Emerson Begay (Navajo) led a workshop on the spirit of the drum, served as a vendor, danced at the powwow and designed the Gathering t-shirt artwork. The powwow host drum was deerclan.com (Cherokee, NC), emcee Scott Crisp (Cherokee descent), and head man/lady Charles (Choctaw) and Siouxsan (Lakota/Blackfoot) Robinson. Manuel's father and stepmother, Manuel Rodriguez and Rosa Martinez Rodriguez, joined Manuel/Karen for the powwow, dinner and Bill Miller concert, and upon conclusion of the Gathering, Manuel/Karen traveled to Chattanooga, Tennessee to spend a little over a week with family there. American Indian Society of Washington, DC Minutes – October 7, 2009 The Church of St. Clement - Episcopal, Alexandria, Virginia

President Michael Nephew called the meeting to order at 8:13 p.m. The following members were present: Mitchell Bush, Karen Collins, Phyllis/Tom David, Eve Hill, Jay Hill, Cathi Hill, Pete Homer, Manuel Rodriguez/ Karen Mallicoat-Rodriguez, Mary Sunbeam, Riccaree/Cynthia/Arthur Vaughan, Joyce Wakefield, Mary Mallett, Glen Dunwoody, Christine Poafpybitty, Marietta VanPelt/Dakotah Adams, Vanessa/Calvin/Amaya/Brooklyn VanPelt, John Moore, Myra Dunwoody and Pauline Prater. Apesanahkwat was presented as a guest. Michael Nephew offered the opening prayer.

The minutes of the September 2, 2009, meeting were read by Cathi Hill and approved as read. Mary Sunbeam presented a pumpkin to the youngest person present, Dakotah Adams. Mary gave the treasurer's report of our accounts. \$7300.00 was made at the Nanticoke Powwow. Mary reported that the CD is in unredeemed status and not earning any interest. The Executive Board will make a decision on the CD, to have it rolled over for another 9 month or year. Marietta VanPelt submitted a proposal to have a separate scholarship fund.
