All auction proceeds directly benefit the AIS Scholarship fund. Nine outstanding students (undergraduate and graduate) were awarded 2004-2005 scholarships, and they attend colleges and universities across the United States and Canada.

January 1 - Mitchell Bush hosted his annual "New Yea" day observance of an old Onondaga custom where people go house to house calling out "New Yea" and receiving cookies or fruit before traveling on to the next house. Early arrivals waited in the club trailer at Indian Pines for the event to begin. Folks arriving at the pavilion called out "New Yea" and were greeted at the door by Mitchell. He gave guests a choice of a fruit danish or an orange. He then said "La Bon Annee, Nih Jih!" to them and they entered the pavilion. That expression is supposed to mean "Happy New Year, My Friend" in the Michif dialect. Verde Halley celebrated his birthday by providing a feast and gifts for all present. Manuel/Karen brought bottles of Sparking Grape Cider for an after dinner toast which was given by Verde. The group then watched "Auntie Mame". Those present included Karen Collins, Chuck/Judy Gray, Manuel/Karen Rodriguez, Marion Cooney, Fred/Mercedes Osborne, Cyril/Marie Taylor, Herb Bush, Brandy Berger/Victoria Cheeseman, Robert Brown and Joe Chavez. The weather was a balmy 60 degrees and it was quite comfortable in the pavilion. When it began to cool down, Verde switched on a propane salamander to warm the pavilion up. Verde had set up his usual Christmas village scene inside the pavilion and set up outdoor decorations.

January 5 - Manuel/Karen Rodriguez and Mitchell Bush met at the Atlantis Restaurant in the Bradlee Shopping Center for dinner before the American Indian Inaugural Ball (AIIB) meeting which preceded the monthly AIS meeting at St. Clement's Church in Alexandria. Those present included the chair, Maria Canellis and the AIS President, Michael Nephew. Also present were Karen Collins (AIS 1st Vice President), Karen Rodriguez (AIS Secretary), Terri Carter (AIS Princess), Manuel Rodriguez, Mary Sunbeam, Eloise Giordano, Jackie Swift, Tanya Thrasher, Justin Giles, Sunny Drew and Mitchell Bush. Maria reported on the AIIB progress. At that time, 32 tables had been sold but she had pending requests for additional tables. Two tables would be set aside for the AIS. Since Floyd Westerman could not make it for health reasons, he asked Keith Secola to stand in for him and accept the award which will be presented for him. Maria is working on securing a drum group to participate in the opening ceremony and ending the evening with round dancing. She is happy with the security to be provided by the hotel and reports that parking for the evening has been negotiated to \$8 for the evening. Maria has also chosen the menu for the evening. From 8-11, there will be a variety of foods available, desserts from 11 on. Also, there will be complimentary non-alcohol drinks. On January 15 at noon there will be a walk through of the AIIB site and on January 20 at 11 a.m. there will be a session for all volunteers. Maria showed the t-shirts which have been designed for the AIIB and remarked that there were independent sales of t-shirts.

January 12 - Felipe Rose (Lakota/Puerto Rican) who portrays the Indian in the singing group VILLAGE PEOPLE donated his gold record "YMCA" to the National Museum of the American Indian (NMAI) and was given the royal treatment by the NMAI staff. Felipe, who now lives in Richmond, VA, cut a CD called "Red Hawk Woman" about the late Thomasina Jordan and the VA Indians bid for Federal recognition. He sang the song at last year's Virginia Council on Indians (VCI) annual conference and gave copies of the CD to those present. Felipe's "Red Hawk Woman" has been nominated for five Nammy's this year.

January 14-15 - The Virginia Council on Indians (VCI) hosted the second annual Tribal Leaders' Summit at the Woodlands Hotel in Colonial Williamsburg, VA. On Friday night, the College of William and Mary hosted a reception in Reeves Hall on the campus for the VCI members and tribal leaders present. Travis Henline (Colonial Williamsburg's American Indian Initiative) and the Williamsburg Mayor, Jeanne Zeidler, were among the guests. After the reception, the group returned to the Woodlands Hotel for dinner. On Saturday, the group met in the Woodlands Conference Center. In attendance were VCI members/staff Karenne Wood/Deanna Beacham/Nita Smith/Reggie Stewart/Frank Richardson/Paige Archer/Danielle Moretti-Langholtz/Frank Adams/Mitchell Bush; Tribal Representatives (Chiefs Anne Richardson, Marvin Bradby, Ken Adams, Steve Adkins; Assistant Chiefs Warren Cook, Gene Adkins, Wayne Adkins, Mark Custalow; Others Pinky/Keith Smith, Bertie Branham/Diane Shields and Reggie Tupponce, Jr., representing VITAL. Chief Ken Adams opened the session with a prayer. Frank Richardson presented an outline of five options for a VA Indian signature event being considered in conjunction with the Jamestown 2007 celebration. Karenne led a discussion on the options. Frank Adams presented an Option 6 for consideration. Karenne requested that tribal leaders inform the VCI by letter before February 20, 2005, whether they wish to participate. Karenne announced the VCI annual conference to be held at the Holiday Inn Central in Richmond on March 4-5; a session on tribal sovereignty and federal recognition at the University of VA, Charlottesville, on March 18-19. There will be a panel discussion on March 19 co-sponsored by the VA Foundation for Humanities called "Pocahontas, an accurate portrayal." The Governors Interstate Indian Council will be coming to VA in August 2005 at the invitation of the VA Governor/VCI. The delegates will attend the NMAI pow wow to be held August 12-14 at the MCI Center and be bussed to Central VA to visit the tribal communities. VCI members were excused after lunch and the tribal delegates held a closed meeting.

January 15 - The National Museum of the American Indian (NMAI) hosted "Let's Round Dance" featuring the Battle River Singers from the Red Lake Band of Chippewas in Minnesota. The singers used hand drums and had a young lady prompter who lead several of the dances. Of course, NMAI was packed with people and many of the tourist types joined in the round dancing. Local AIS and community members who turned out for the event held in The Potomac Rotunda were Michael Nephew, Karen Collins, Manuel/Karen Rodriguez, Eve Hill, Phil Hill/Cathi Obenstine/Alexis Obenstine-Hill, Edna/Jose/Weewee/Andrea Campos, Tom/Phyllis/Jessica David, Erlette Lamont/Josh Hill, Will Reeves,

Tim Moore, Barbara Driftmeyer, Chris Davidson, Katherine Fogden, Naomi Little, Fred/Mercedes Osborne, Christian Kane Bentley, Debbie Moore, Jennifer Beinhacker, Rico Newman, Jay Nightwolf, Anna/Dora Old Elk, Leon Leuppe, Georgianna/Lillian Sparks, Shana Greenberg, Ellen Trancosa, Joe Vasquez and Mitchell Bush.

January 17 - Jeff Ball and group performed at the Francis Scott Fitzgerald Theater in Rockville, MD, as part of a Martin Luther King observance. Michael Nephew and Josh Hill danced in accompaniment to his music. The performance was well attended by the general public.

January 19 - Kicking off the American Indian inaugural activities, the Native Youth Alliance (NYA) hosted the Inaugural Pow wow at the Marriott Crystal Gateway hotel in Arlington, VA, under the supervision of Nathan Phillips/Shoshana Konstant. Don Neconie served as the emcee; head man dancer was Nathan Longhorn; head lady dancer was Feather Chicharello from Denver, CO. The host drum was Black Bear (Pete/Don Neconie, Paige Burgess, Jeff Bailey, Manuel Rodriguez with Rochellda Sylestine as chorus girl). The VEVITA Color Guard (Richard Begay/Kim Sowinski/Randy Curley/Leander Sage/Demetria Simms/April Taase) took part in the opening ceremony. Dave Henderson was the soundman. Although there were not too many dancers, many of the out-of-town Indians in town for the inaugural, as well as some of the hotel's other guests who heard the drum, dropped in. In addition to the head man/lady, dancers included Ray Couch, Joe Chavez, Verde Halley, Jay/Josh Hill, Mercedes Osborne, Marion Cooney, and Shawndae Dawson in regalia but several others joined in the social dances. A 50/50 was won by John Buck of CORN BRED, one of the bands in town to perform for the American Indian Inaugural Ball, and he donated his winnings back to NYA. Local folks who turned out for the pow wow included Michael Nephew, Karen Collins, Karen Rodriguez, Terry Snowball/Machel Monenerkit, Christian Bentley, Phil Hill/Cathi Obenstine/Alexis Obenstine-Hill, Ollie/Irving/Josh Henderson, Fred Osborne, Gene Barnes, Erlette Lamont, Vivian Dawson/Inez Miller/Greg Sharp, Georgia Gibson, Wanda Lee, Shawna Robbins, Luis Zapata, Sally/Harold/Theresa White, Joe Whatmough, Mary Hope Billings, Eloise Giordano, Georgianna/Lillian Sparks, Maria Canellis, Martha Redhouse and Mitchell Bush.

January 20 - U.S. Senators George Allen and John W. Warner from VA hosted a coffee in the Russell Senate Office Building on Capitol Hill in DC. Among the VA Indians who attended were Steve Adkins (Chickahominy Chief), Ken Adams (Upper Mattaponi Chief) and Reggie Tupponce, Jr. (President of VITAL). Elizabeth Walker of Walker Associates, coordinator for the VA Indians' federal recognition effort, was also present. The January 21 edition of the RICHMOND TIMES-DISPATCH and January 23 edition of the FREE LANCE-STAR (Fredericksburg, VA) carried stories about the coffee/reception.

January 20 - The American Indian Inaugural Ball (AIIB) hosted by the American Indian Society (AIS) was held in the Arlington/Grand Ballrooms of the Marriott Crystal Gateway hotel in Arlington, VA. Included as sponsors were those tribes, casinos, lawfirms, and individuals who purchased tables. Sponsors at the Gold, Silver, Bronze, and Friends & Family levels sat at reserved tables, although there was an addition this year of many smaller tables/chairs for those that weren't at reserved tables. The AIIB Chair was Maria Canellis and the AIIB Honorary Chair was actor Adam Beach (Saulteaux). The emcees were Drew Lacapa (Apache/Hopi/Tewa) and Vanessa Short Bull (Oglala Lakota). Bands included Corn-Bred (Onondaga Territory, NY), Derek Miller (Canadian Six Nations), Martha Redbone (Lumbee / Shawnee / Choctaw),

and Stateline (Navajos from Whitecone, AZ). A Lifetime

Legacy Award to Floyd Red Crow Westerman was accepted on his behalf by friend and musician Keith Secola, with a letter from Floyd read by his long-time friend and fellow activist Dennis Banks. Floyd is recovering from major surgery and could not travel to accept the award. Actor/director/producer Rick Schroeder and his wife attended the Ball as guests of the Seneca Nation. The festivities began with a Grand Entry. Host drum was Black Bear (Don/Pete Neconie, Paige Burgess, Clayton Old Elk, Jeff Bailey, Jody Cummings, Dennis Zotigh and Wallace Coffey). The Indian Nations Warriors & Veterans Honor Color Guard and VEVITA Color Guard led the grand entry followed by AIS representatives (Michael Nephew, Terry Snowball, Mitchell Bush, Machel Monenerkit, Karen Rodriguez, AIS Princess Terri Carter and AIS Jr. Princess, Ciera Snay), Honorary Chair Adam Beach, and tribal leaders. Outside of the ballroom, Tanya Thrasher and her helpers, William Cabeza/Lillian Thrasher/Keevin Lewis, set up a Silent Auction with proceeds benefiting Scholarship Fund. Artists, individuals and organizations who donated art to the auction included Tony Abeyta, Frank Hyde, Tom/Phyllis David, Pete Yazzie, Emil Her Many Horses, NCAI, Cherokee Nation of Oklahoma, The Indian Craft Shop, an Anonymous Donor, National Geographic, Ho-Chunk Nation, and Gwendolen Cates. Volunteers handled the sale of AIIB Programs and AIIB t-shirts designed specifically for the ball by Native

Threads, another of the ball sponsors. Both the program and t-shirts were professionally done and quite in demand as souvenirs of the ball. Karen Rodriguez was in charge of the volunteers who worked long and hard. We needed volunteers for ticket-taking, wrist bands, will call, t-shirts and programs and goodie bags. The food was delicious, plentiful and the staff/servers were helpful. Tables of tired ball goers enjoyed the meal but, for a few volunteers, there was still a little work to do - selling t-shirts and programs and distributing more goodie bags!

Rick was survived by his wife, Joan, son John Harrison and daughter Rikki Ann Lovett, and several stepchildren, Debra Ward/Sandra Meinberg/Linda Hazlewood/Patricia Haga/Michael Doyle and David Doyle. Rick's obituary was published in the WASHINGTON POST on January 20, 2005. Unfortunately, most of the Indian community was at the American Indian Inaugural Ball and did not learn of his passing until after the funeral. Our thoughts, however, are with the family.

American Indian Society of Washington, DC Minutes – February 2, 2005 St. Clement's Church, Alexandria, VA

First Vice President Karen Collins called the meeting to order at 8:10 pm. She introduced member Steve Gonyea to the newer members.
